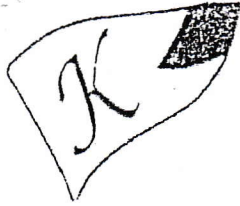

KIYC Membership Fees and Entitlements

**** Memberships are non-transferable**

The anniversary date of membership dues shall be the month of enrollment. Payments submitted with the application will be returned if the application is not accepted.

Full Member:

Annual Dues- \$520

Initiation Fee- \$250

- Full use of the facilities, including pool and special events
- The right to vote
- The right to apply for boat slip in the marina
- Eligible to serve as an Officer or Member of The Board of Governors at Large

Young Adult Member:

Annual Dues- \$365

Initiation Fee- \$50

Young adult members must be between 21 and 35 years of age when application submitted.

- Full use of facilities, including pool and special events
- The right to vote
- The right to apply for a boat slip in the marina

Non-Resident Member

Annual Dues- \$260

Initiation Fee- \$0

A Non-Resident member is defined as a person who is a permanent resident of a state other than Maryland, as evidenced by driver's license, voter's registration, or other government issued documentation, and does not maintain any residence (house, boat, condo, RV, etc.) within 200 miles of the Kent Island Yacht Club.
